## FUNFLY AEROSPORTS FLYING CLUB MEMBER TERMS FOR AIRCRAFT USE

I note that any flight I have with a club flight instructor is for instructional purposes.

I will possess valid pilot license and medical certificates for each flight conducted as required and will meet all Regulations concerning currency.

**I confirm that I have had no Aviation Accidents or Claims in the last five years. If I have an aviation accident or claim I will immediately inform FunFly Aerosports Flying Club and the Aircraft insurer. Signed: \_\_\_\_\_**

I agree to maintain my Club membership dues and pay the posted and prevailing hourly rates for the club aircraft, including any fuel surcharges or other operating charge(s), which from time to time may be assessed.

I agree to the Club holding, either on computer file or otherwise, my personal details as above and using this information as necessary to keep my account up-to-date and to maintain the Club's membership list and for Club business.

I understand that taking part in aviation activities may invalidate personal life or other insurances such as I may have and that the Club does not provide personal insurances.

All landing fees, tie-down, hangar fees or other fees incurred while the aircraft is in my care, custody or control is my responsibility.

FunFly Aerosports Flying Club will pay all fuel and oil bills incurred for said aircraft directly via equivalent deduction or by reimbursement. If Avgas is uplifted, it shall only be reimbursed at the Mogas rate.

I agree to pay for the use of the aircraft upon the completion of the flight either by cash, cheque, credit/debit card or EFT.

I will not operate the club aircraft into and out of airfields less than 400 metres without the written permission of the FunFly Accountable manager.

I will not operate the aircraft on a flight outside the Island of Ireland without the written permission of the FunFly Aerosports Accountable Manager.

I will return the aircraft to FunFly Aerosports Flying Club at the scheduled date and time to avoid inconvenience to other Members. In the event of a weather-related or mechanical delay, I will notify FunFly Aerosports Flying Club as soon as possible of my intentions.

In the event the aircraft must be left at another airport due to weather or mechanical delay, it will be my responsibility to coordinate arrangements with FunFly Aerosports Flying Club prior to returning the aircraft to Limetree Airfield. The cost to reposition the aircraft may be charged to the member.

I will inspect and make a ground check of the aircraft, its equipment, and accessories before takeoff and will not accept the aircraft until I am satisfied with its airworthiness (including required inspections and documentation) and the proper functioning of its equipment and accessories (per the Aircrafts POH).

I will observe all air safety regulations and comply with SERA.

I will comply with posted rules concerning required flight time in various makes and models of aircraft.

I will not carry passengers unless I have at least 3 takeoffs and landings in the past 90 days in the category and class/type of aircraft being flown.

I will use the Club aircraft only for personal business or pleasure and will not conduct commercial operations. I understand that flight instruction may only be given by instructors authorised by FunFly Aerosports Flying Club and scheduled through the FunFly Goboko site.

I will permit no other persons to act as pilot in command, except during training flights with FunFly Instructors.

### AIRCRAFT DAMAGE AND REPAIR

As Pilot in Command, I will report all Aircraft accidents or incidents, major or minor, to FunFly Aerosports Flying Club as soon as possible, including names and addresses of witnesses and involved parties (including passengers). In the event of an accident, I will not move the aircraft until specifically authorised by FunFly Aerosports Flying Club and, if required, the IAA or the AAIU.

I will not have repairs made to any part of the aircraft or its equipment without specific authorisation from the FunFly Aerosports Accountable Manager. I will contact FunFly Aerosports for repair instructions/ authorisation in the event of a malfunction of any part of the aircraft or accessories. In the event of required mechanical repairs where the estimated down-time exceeds 24 hours, I have the option of:

1. Returning by other means at my own expense, in which case expenses incurred in bringing the aircraft home will be borne by FunFly Aerosports, or

2. Remaining with the aircraft at my own expense until repairs have been completed enabling completion of the planned flight and return to Limetree Airfield.

I further understand, in case of my negligence or recklessness, that FunFly Aerosports Flying Club and/or its insurance carrier may make a claim against me for damage to the aircraft that exceeds the deductibles.

**CANCELLATIONS:** Cancellations not related to weather, aircraft availability or personal emergencies shall be made 4 or more hours in advance be to ensure availability of aircraft for other club members.

No-Shows will be charged a penalty of 50% of the hourly rate of the aircraft scheduled for the number of scheduled hours. This will be added to the cost of the next flight in a club aircraft.

Cancellations must be made via Goboko; the time stamp of which will be used as the recorded official cancellation time. Abuse of Goboko resulting in frequent cancellations may disqualify the pilot from further Club aircraft privileges.

FunFly Aerosports Flying Club reserves the right to reschedule previously reserved aircraft if the previously reserved aircraft has not been checked out, and the customer has not notified FunFly Aerosports Flying Club of being late within 15 minutes of the scheduled reserved time.

**MINIMUM USAGE TIMES:** Unless delayed by weather or aircraft availability, aircraft scheduled for over twelve-hour blocks, or overnight, will be billed a minimum of 3 hours per day. Aircraft scheduled for 4-hour blocks are subject to a 2-hour minimum Flight Time.

**FLYING CLUB:** The flying Club has yearly dues of €250.00 and are due annually on July 1<sup>st</sup>. They will be reduced on a prorated basis throughout the year as per the table below. This rates only apply to new members. Membership renewals will be charged at €250 regardless of when they are paid and will always expire on the 30<sup>th</sup> June. The yearly dues amount may be amended by the club and the club will give 30 days written notice of any change.

I understand that this agreement may be withdrawn at any time and is for a 1-year period unless terminated by either party with a 30-day written notice.

This Club members Aircraft Use agreement may be updated at FunFly Aerosports Flying Club's sole discretion from time to time. The latest version of this agreement will be posted on FunFly Aerosports Flying Club's website and any changes in terms are binding upon publication. FunFly Aerosports Flying Club will also email the new agreement to all pilot's email address on file in the event of any changes.
